The Regulations:

Regulation 53 of the Road Traffic (Registration and Licensing of Vehicles) Regulations, Chapter 374E of the Laws of Hong Kong

• Control Subject Matter

• A movement permit will only be issued to a vehicle that is (a) not licensed; (b) not normally used on a road from design and construction perspective; and (c) driven on a road only for the purpose of proceeding from one site to another.

• Conditions of the Permit

- The vehicle is to be driven on the road by a person holding a valid driving licence of the relevant vehicle class;
- The vehicle is to be moved during the time and route(s) specified in the permit, and at a speed not exceeding the speed limit specified in the permit; ;
- When the vehicle is used on a road, it shall be covered by a valid third party risks insurance required by the Motor Vehicles Insurance (Third Party Risks) Ordinance (Cap. 272) as if it were a motor vehicle registered and licensed in accordance with the provisions of the Road Traffic Ordinance (Cap. 374) and the regulations made thereunder, and
- Other conditions as imposed by the Commission for Transport.

How to Apply:

- The vehicle owner should submit a duly completed application form "Application for a Movement Permit for a Vehicle" (TD 298) at least one month in advance with the following information:
 - (a) specifications of the vehicle;
 - (b) drawings of the vehicle showing configuration, spacing of wheels and overall dimensions;
 - (c) photographs of the vehicle (front view, back view and side view); and
 - (d) copy of assignment or written confirmation from the agent concerned requiring the movement of the vehicle (if applicable).
- The following documents should be produced upon issuance of the permit
 - (a) identity document of the vehicle owner;
 - (b) a valid third party risks insurance covering the use of the vehicle in the name of the owner; and
 - (c) proof of present address (residential address/company address and correspondence address) which is issued not more than three months from the date of permit issued.

- A movement permit is issued shall be valid for the period as specified by the Commissioner for Transport and subject to such other conditions in regard to the time when the vehicle may be moved.
- When the vehicle is being used on a road, no load is carried on the vehicle other than such equipment, spares or fuel normally carried on the vehicle. 4.
- The vehicle is to be driven on the road only by a person holding a valid driving licence authorizing him to drive a vehicle of that class.
- When the vehicle (with the exception of a trailer) is driven on a road, it shall be covered by such insurance required by the Motor Vehicle Insurance (Third Party Risks) Ordinance as if it were a motor vehicle registered and licensed in accordance with the provisions of the Road Traffic Ordinance and the regulations made thereunder.
- When the vehicle is driven on a road, it must be accompanied by an escort vehicle in the front and another at the rear (if applicable).
- A recovery vehicle should be available all the time the vehicle is on the road.
- Emergency warning signs must be carried and used in the event of a breakdown.
- Police should be informed when a breakdown occurs.
- 11. A telephone number is to be displayed on the vehicle which will provide Police with 24 hours access to the owner or his representative.
- The permit shall be displayed on the front of the vehicle left hand side of the front windscreen of the vehicle in such a manner that it is clearly visible 12 from the front of the vehicle.
- 13. The permit must be returned to the Commissioner for Transport in case of cancellation.
- 14. Operation of the vehicle is subject to additional conditions recommended by the Police/Highways Department which are attached to the permit issued.
- 15. Contravention of any of the permit conditions may render the permit liable to cancellation and a fine of \$2,000.
- The permit holder shall seek the approval from the relevant authority prior to driving the vehicle in any area or private road of which the management authority or owner may restrict the access of the vehicle.
